3. OTHER BUSINESS

- Parish President Josh Guillory
 President Guillory reflected on the accomplishments he has done in the parish in the last
 4 years. They have invested heavily in the parish 1.25 billion gallons of storage for
 drainage. They have paved more than 210 miles of roadway and they have also invested
 in public safety and fire protection and the quality of life for the citizens of this parish.
 All the Mayors of the parish meet once a month to discuss the needs of every town/city.
 Public Works Directors of the Parish meet every other month. We have a strong
 economy in the parish and only a 2.8% unemployment rate. The parish is more unified
 than it has ever been. He feels the parish has a future brighter than ever. He thanked
 the council for their past support and asked for their vote on Saturday. Mayor Bourque
 thanked President Guillory for the contract coming up later in the meeting for the
 assistance of mutual aid for firefighting with the City. He knows the Chiefs throughout
 the parish worked very hard on this.
- 3.2 Report on condemned property: 107 N. Eola Road / Carolyn Lebleu Property
 Ben Theriot stated the property was previously condemned by the council. Since
 then, they have sold the property. The new owner asked for additional time to clean
 up the property. He has already submitted plans to the permitting department. Ben
 questioned if we need to reverse the condemnation? Oscar stated we can get it
 reversed with the mortgage department. Councilman Bonin questioned if the house is
 repairable? Ben stated yes, it is.
- Appeal of Condemnation of 400 East Third Street/Jason & Angela Richard Property 3.3 Ben stated the property was previously condemned, but the owner has appealed the condemnation. He did a site inspection and gave the council a copy of the report. The property does look worse on the inside. The homeowner would like to address the council. It is past the 30-day action period. Mrs. Richard addressed the council and stated she has not lived there in over a year. The property does need to be condemned, but she is asking for time to clear out the home and come up with the money for the condemnation. Mayor Bourque questioned Mrs. Richard about how long does she need? Mrs. Richard stated she would like to have till after the holidays. Councilwoman Girouard questioned Mrs. Richard if she has a quote for the demolition? Ben stated, ves, she does. It is under \$6,000; but the demo company will go back and look at the property being the home is getting cleaned out. Mayor Bourque stated if the council elects to give Mrs. Richard more time, he feels the home needs to be secured. Mrs. Richard stated it had been locked up. No one has entered the home. Councilman Delahoussave recommended we give Mrs. Richard till the first meeting in January and have Ben report back to us on the progress and if nothing has been done, we can be

ready to condemn the property. The council agreed with the recommendation from Councilman Delahoussaye.

3.4 Report on condemned property: 304 East Madison/Douglas & Willa Chesson Property Ben stated he talked to the owner today. She has a buyer for the property, but she is trying to get an appraisal on the property. If the owner does not sell the property, they will tear it down and just leave the lot empty. Mayor Bourque recommended we give the owner 10 days to get the property under contract or she needs to proceed with the condemnation. Councilman Delahoussaye recommended we give the property owner till the Nov. 28th meeting. The council agreed with the recommendation.
