It shall be unlawful for any person, firm, or corporation to sell, set off, or shoot any fireworks of any kind or character, including but not limited to firecrackers, roman candles, torpedoes, sky rockets, and any other fireworks of any similar kind or character, within the city, except as may be specially permitted by the city, in writing; except that it shall not be unlawful for a person, firm, partnership or corporation to sell at retail, and fireworks may be used, set off or shot in accordance with the following times and chart:

BE IT KNOWN, that on this 18th day of March, 2024, before me, the undersigned Notary Public, duly commissioned and qualified as such in and for the aforesaid Parish and State, and in the presence of the undersigned competent witnesses, personally came and appeared:

MODERA PLACE, LLC, herein represented by its Members, Paul Tylock and Jesse Regan, hereinafter referred to as "Appearers"

who, after being first duly swom, did depose and declare that Appearer is the owner or the authorized representative of the owner of certain property more fully described as follows, to wit:

That certain parcel of ground, together with all improvements thereon, and all rights, ways, privileges, servitudes, advantages and appurtenances thereon and thereunto appertaining to be known and declared as Modera Place Subdivision, located in the City of Broussard as shown and set forth in that certain plat of survey prepared by Adam Meche, Registered Land Surveyor, dated the 6th day of March 2024, a copy of which is attached hereto and made a part hereof.

Appearer has submitted the hereinabove referenced and attached plat of survey to the City of Broussard in order to obtain plat approval. In connection therewith, and in order to obtain such approval, Appearer does by these presents make the following dedications:

- I. Appearer dedicates to the public all infrastructure associated with the gravity sewer system, sewer forcemain, sewer lift station, and water system as referenced on the plat of survey referenced herein and attached hereto; it being the intention of Appearer to statutorily dedicate same in accordance with La. R.S. 33:5051. The statutory dedication(s) made herein shall not apply to any road, street, alley, cul-de-sac, rights of way, rights of passage or other avenue or route for ingress and egress expressly marked or noted on said plat as being either private, or where the ownership of same is expressly reserved by Appearer. Where ownership of same is expressly reserved by Appearer, of a servitude of public use in and to said roads, streets, alleys, cul-de-sacs, rights of way, rights of passage, and other avenues or routes for ingress and egress in favor of the City of Broussard ("City").
- II. Appearer further dedicates to the City, that parcel of land identified as CA4, located at 122 Modera Place Drive, as referenced on the plat of survey referenced herein and attached hereto, together with the sewer lift station infrastructure contained within this parcel.
- III. Appearer further dedicates and grants perpetual predial servitudes in favor of the City, and such other persons, entities or estates who are given authority by said City, to use all servitudes, easements, rights of way and other noted areas for public use, as shown on the plat of survey referenced herein and attached hereto, or who may as a result of this grant of perpetual predial servitudes derive any benefit therefrom, and in connection therewith Appearer agrees that the City, and any such persons, entities and estates as are authorized by the City, shall have access to said perpetual predial servitudes for the purpose of (i) constructing drainage, electric, sewer, water, gas, traffic control, telecommunication, and other utility facilities; (ii) repairing, maintaining, upgrading, improving or otherwise operating any and all facilities placed in or upon the perpetual predial servitudes dedicated herein. In connection therewith, the City, and any such persons, entities and estates as are authorized by the City, may, within the confines of said perpetual predial servitudes; remove all obstacles which would hamper or preclude the exercise of the perpetual predial servitudes dedicated; and otherwise have full access for the purpose of utilizing and maintaining the perpetual predial servitudes dedicated; and otherwise have full access for the purpose of utilizing and maintaining the perpetual predial servitudes dedicated and any improvements hereafter or heretofore constructed therein, or thereon.

Appearer agrees to provide for the perpetual maintenance of any easements, water, sewer, including sewage receptors of effluent and other discharges from any and all sewer systems, drainage, drainage ditches, including roadside ditches, or other items dedicated herein until said items have been formally accepted for perpetual maintenance by the City. Until such acceptance for perpetual maintenance by the City, Appearer will perform and will take all actions necessary to maintain, clean, clear or improve said items dedicated as necessary and/or required by law.

In connection with the exercise of the use of the dedicated areas and servitudes created hereby, the City, for the ultimate benefit of the public and any other persons, entities or estates, shall have such access as is appropriate or reasonably necessary, both within and without the actual confines of the dedicated areas and servitudes, as same are shown on said plat, to access said dedicated areas and servitudes in order to maintain same, improve same, construct appropriate improvements, structures and appurtenances with regard thereto, in accordance with the relevant provisions of the Louisiana Civil Code, and in particular Article 745 thereof.



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BROUSSARD, LOUISIANA, ABANDONING PORTION OF DRAINAGE SERVITUDE
