Discussion: Deputy Chief Denais addressed the council. Denais stated at the start of the budget year they had \$85,000 for the paid on-call allocation. As of the beginning of February they had \$22,000 left. They need \$40,000 to get thru the end of the fiscal year. August – September. They have had 10 new members come onboard. Denais stated the first year they did this they requested \$90,000, the second year \$80,000 and in 2018 and 2019, they did not request anything. Last

year they used \$120,000 and this year \$125,000. Right now, they have an average of 12 firemen per call, instead of only 3 fulltime firemen at a fire for the same cost. They have been very busy the last couple of weeks.
