Discussion: Karen stated we received the first FEMA reimbursement from Hurricane Laura. We claimed about a half of million dollars' worth of losses. Also, in the meantime the America Rescue Plan has been signed. The City of broussard should be getting about 4.68 million dollars from this plan. It will be divided into 2 payments. We can use it on water and sewer infrastructure and loss of revenues. Mayor Bourque stated that we have projects, this money will be allowed to be used on.

4. OTHER BUSINESS

4.1 Acadian & Indigenous Association of Louisiana

Proclamation recognizing the French Language

Mr. Calvin Leger addressed the council. He thanked the Mayor and Council for approving a Proclamation recognizing the French Language. Members also associated with his group read the proclamation. This proclamation is to acknowledge the bilingual accessibility and to encourage our local businesses to do business in French and English.

4.2 Daniel Hutchinson

Proposed J-Turn for S. Bernard Road

Daniel gave all of the council the plan the traffic engineer and their personnel came up with. They are proposing a J-turn #1 on the southside of Heart D Farm. Also, J-Turn #2 is proposed further down near the day care. In the section of Albertson Parkway and Ambassador, it is narrow to put J-turns. #4 and #5 are planned for across Albertson Parkway for single unit trucks. Mayor Bourque stated at Ambassador Caffery and South Bernard there is a medical facility coming behind Hebert's. J-turn #3 is incorporated to access the driveway in that area. This is merely for discussion tonight. We are not voting to fund anything. Current estimated costs of J-Turns are: J-turn #1 \$165,000 for passenger car; J-turn #2

\$165,000 for passenger car; J-turn #3 \$230,000 for passenger car; J-turn #4 \$165,000 for passenger car and J-Turn #5 \$235,000 for single unit truck. Councilman Delahoussaye questioned about J-turns 2 and 3 and 1 and 2, you have a business and #2 you have nothing, so is #3 to get people off the road? Daniel stated it will allow you to access the daycare and other one is the opposite. Councilman Higginbotham questioned if this will be soil cement? Daniel stated it will be a base and asphalt. Councilman Bonin questioned Karen if we can afford to do all 3? Karen stated it would be easier to break it into chunks. Walter stated the bigger the project, the better the unit price. Mayor Bourque asked Daniel if the Jturns need to pair together? Daniel stated yes 2 and 3 first and 1 is stand-alone. Walter stated they looked at the section of Albertson Parkway and Ambassador too, but it is too short and not practical. Mayor Bourque state the council has funded the waterline there, but we still need to do the lights and fund the sewer. Councilman Higginbotham questioned if this would go into the next budget year? Mayor Bourque stated he is not asking the council to amend the budget now. This is for their information only and they can decide what they want to do. Councilman Gary stated he feels J-turn #2 and #3 are the most important. Councilman Delahoussaye, questioned if we are getting the 4 million dollars, what is the time frame we are looking at? Karen stated we cannot use that money for roads. Councilman Delahoussaye stated we can perhaps use it for the water and sewer. Karen stated after the bill is passed then we should get the money 60 days later. Mayor Bourque stated as we fund the projects, we can see as the money is coming in. Councilman Regan questioned, if we will also permanently address the in and out of Sable Palms 3 where the gravel is now? Walter stated that was put there only for the construction, it was not put there for everyone to cross. When the Jturn is built they will have enough j-turns to use to make the roadway safer. Mayor Bourque stated he would request the council consider funding J-turn #3 in the future. The entire council stated they would like to fund #2 and #3. At the next meeting, Comeaux Engineering will have the figures so an ordinance can be introduced to amend the budget to get this project rolling.
