Mayor Bourque questioned Karen, which events are the FEMA request from? Karen stated from Hurricane Laura and Hurricane Delta. We usually get 75 reimbursement, maybe 90%. Councilman Higginbotham questioned if it comes thru the Federal Government? Karen stated it flows thru Homeland Security.

Mel stated these roads are both owned by DOTD, but he has confirmed with the State, that they do not have set-back regulations on these roads. Councilman Bonin questioned, if there is so much more money to be made to come and ask for an additional 10 feet? Travis stated the extra 10 feet uses up 2 units. They are

going by the size of the units here and the Fire Marshall requirements. They already have to reduce the size of the building, because they will be putting in an economy unit,
