Councilman Rabon stated it came very close for 1 home in Ridgeview Subdivision and there was another one on East Broussard. Mayor Bourque stated that Ben spent some time with Councilman Rabon looking at this. Councilman Delahoussaye questioned if there are any plans for the ditch behind his home?

Walter stated they will begin cleaning from the silt plugs and high points and work on getting the under brush cleaned out. Councilman Delahoussaye stated in 2016 there was 2 feet of water there and with this last rain there was 1 1/2. Walter stated in the area of the Janin Farms, there is still areas under water in the swamp. This is something they will be doing a little at a time. In some areas they cannot start doing it now. Councilman Higginbotham questioned about the new construction in Cypress Meadows with all of the dirt on the roadway; how is this affecting the drainage? Walter stated with the new construction there is silt going in the drainage, but they are maintaining it. The areas with curb and gutter are being monitored. Councilman Higginbotham questioned if we run cameras thru the drains before we accept a subdivision? Mel stated yes. Ben stated the developers and home builders have been very cooperative. Councilman Bonin stated he is on the drainage committee and he feels we need to keep working on drainage. He is asking the council not to short-change the budget and keep it going. He is asking to keep financing whatever Mel and Daniel put together.

He feels it would best be served as a Welcome Center or a Gathering Place for the citizens. It would definitely be

beautiful at Christmas time all lit up and for Mardi Gras. He feels we should purchase this home because we should preserve this piece of history. Councilman Bonin stated he would be proud to have his name on this paperwork to buy this home. We need to preserve this home.

Mayor Bourque stated this home is on the National Registry. It is the oldest home in the city. This was the home of Valsin Broussard, the founding father of Broussard who also donate the land where we see Sacred Heart Catholic Church, St. Ceceilia School, and the former Railroad Depot. Valuing our culture is very important. We do have a rich and economic culture. We are spending a lot of money in downtown Broussard, this is good for Broussard. This home has been in the family for 150 years and he is proud that we are given the opportunity to purchase it.
