3.1 Approval of the April 2020 Financial Report

Discussion: Karen stated the April financials were in their packet. We have not seen a dip in revenues yet. Right now, the departments are right where they should be or a little below budget. Councilman Higginbotham stated they heard there needs to be a 25% budget reduction for 2020/2021. Karen stated our municipal advisor originally said 25%, but the Mayor spoke to Burton today and he recommended 15%. Mayor Bourque stated that initially it was unfair what the advisors were first recommending, because you cannot put everyone in the same category. We are still monitoring everything closely and we are fortunate we are ok. Councilman Higginbotham questioned, if they recommend reductions in the budget? Karen stated we would reduce over the expenses. Mayor Bourque stated it is a matter of priorities. Councilman Higginbotham stated he is just concerned that Lafayette Consolidated Government laid off 125 workers last week. Karen stated that is not on our radar at this point. Mayor Bourque stated we are projecting ahead of any downturn and we will still provide services to our citizens as needed.

## 4.2 Adopt Resolution #632-20

To adopt Resolution #632-20, a resolution authorizing the Mayor to execute a memorandum of understanding between the Louisiana Department of State, Office of Secretary of State, the Lafayette Parish Registrar of Voters, Lafayette Consolidated Government, the City of Broussard and the City of Youngsville to provide for funding for an additional early voting location in the Broussard-Youngsville area to be utilities for all local, state and federal elections. Discussion: Councilman Josh Carlson with Lafayette Consolidated Government addressed the council. Carlson stated about a month after he took office, there was talk from the Registrar of Voters Office about opening up an early voting site on this side of town. After leaving the meeting, he looked into and at that point they did not know if this could happen. With the help of Mayor Bourque and Mayor Ritter, they came up with a plan. If this is accepted it will be a great benefit for residents on the Southside. For the next two years, they will find a funding source for the Lafayette Parish Council. The only leg work to tackle will be one site for Broussard and Youngsville, which the site is East Regional Library. Councilman Bonin guestioned if they could use the funds the library has in reserves? Carlson stated that would have to go to bond counsel for an answer. They will also have to provide security. The first year the cost would be \$62,013 and the second year it would be \$40,863. The City of Broussard and Youngsville would be granting money to the Lafayette Parish Council for this.

#### 5.1 Introduce Ordinance #20-646

Karen stated after we adopt the ordinance they will wait for the rates to be good, before they are refinanced.
