# 3.1 Ms. Dona Renegar

Candidate for Family Law Judge Division M

He will offer this system to the area local towns also for their court system. If elected City Marshal, he plans to bring compassion and realistic plans to improve the Marshal's Office. Candidate for District Court Judge Division K
