It would be a more positive thing for the community. She has had several people check out the roof to re-do it. She cannot get a permit for electricity because of the condition of the roof. Councilman Higginbotham, questioned how far is she on this? Ms. Norbert stated that someone looked at it and gave her bids. She needs someone dependable to do it. Councilman Higginbotham stated we need to know what is the time frame she is looking at. Mayor Bourque stated once she has contract signed, that will show as the timeline for proof. Mayor Bourque stated we need to send in our inspector to see what needs to be brought up to code. Mayor Bourque stated he would like her to collaborate with the inspector to get everything back in order. Councilman Delahoussaye questioned her what is her budget for this? Ms. Norbert stated she has a partner that will do the inside. She has pulled out the electrical in the building. Ms. Norbert did not give a definite answer of how much she has budgeted for this. Councilman Delahoussaye stated he is willing to give her 30 days to come back to council after she meets with the inspector to see what needs to be done to bring the building back to code. We will in turn get the report from Mr. Cooney Richard.
