We have been paid for the expenses from Hurricane Ida and all we are waiting for the expenses from Hurricane Laura. Sales Taxes are running 13% above overall. Councilman Higginbotham questioned if FEMA is a budgeted item? Karen stated it is an Intergovernmental Revenue. It is outstanding from last year. We are just collecting on what is owed. Mayor Bourque stated all of the FEMA paperwork is managed in house by Mel and his staff and they do a fantastic job doing it.

4.1 Burton Kolder

2020/2021 Audit Report Review

Motion by Councilwoman Racca

Second by Councilman Regan

Discussion: Burton stated we had a great year. There were no findings with only 3 minor verbals that have been corrected. Burton did a re-cap of the report as follows:

Utility Fund: Garbage revenues have increased from 2020 by \$80,000 and so have the expenses. After all is said and done, we did have a profit last year in the garbage. In the sewer we are slowly closing the gap of where we were in the past when we were losing money. In the next 2 years the sewer should be at a positive cash flow. The water revenues have also increased. The biggest item is the water purchase. The old well behind City Hall was decommissioned to save expenses, because it would have cost us quite a bit of money to drill a new one. So, we currently buy from the City of Lafayette. Water next year could be at a break even stand-point. On page 2 of the hand-out, it shows the increase of customers versus revenues of customers. We are at a steady progress upwards. Sewer we have

increased 200 customers each year. We are slowly progressing to a positive flow. Garbage the loss is steadily going down. This is helping with the gradual rate increases.

Park and Recreation Fund:

The total expenses are close to last year with a 40% depreciation. The Sales Tax is generating enough to cover the loss. The park does have an impact on the city. Handout:

Burton went over the re-cap with the handout showing a comparison of total fund revenues and expenditures to budget. Sales tax is up 22% from last year. Total revenues are \$26,872,825. The revenue variance from budget is 0.57%. The expenditures are up from last year which is a budget variance of -0.73%, which is exceptionally good. On page 3, the Sales Tax TIF Fund, Burton stated this is a 10-year payout. We have right at about 8 million collected. The TIF is re-paying the \$10,000,000 the city paid for the construction of Ambassador Caffery. The state is re-paying this back to the city.

Burton stated at a net position we can operate for 164 days without taking in a dime. That is 5 months which is exceptionally good. In just the General Fund we can operate 8.5 months with the available reserves we have.

Mayor Bourque stated our revenues are up, but our expenses did come down. Because of the explosive growth we are funding a lot of projects. In the meantime the cost of materials is rising. Burton thanked the mayor and council and the staff for working with him on this.
