3.1 Condemnation of 307 East Third Street (Marcombe Property)

Discussion: Mr. Rodney Richard stated he inspected this property on Feb. 24th The mobile home is in very bad condition. The insulation is falling down at the bottom due to moisture. The floor is very weak. The panel box is also exposed to the weather. The shed that was being torn down had 1 wall standing. The shed apartment in the back someone was living in it and running an extension cord from the trailer for power. Mr. Richard recommended to the council the property be condemned and demolished. Mr. Marcombe stated he has done a lot of work to the property. He stated that Mr. Richard needs to go inside and look at it. He stated the breaker panel was changed along with doors and windows. Mr. Richard stated he passed by this afternoon to inspect it and the panel box is being used as a junction box, which is against the code. Mr. Richard stated he would like to go inspect the inside of the mobile home. Mr. Marcombe stated he did not know the process, which is why he reached out to Mr. Richard this morning. Mayor Bourque stated in Mr. Richard's initial report the mobile home was unfit for human occupancy. Mr. Marcombe stated a lot of people have inquired about renting it. Councilwoman Racca questioned if there is running water in the trailer and is someone living in it. Mr. Marcombe stated there is no running water and a vagrant was living in it? While he was repairing it, he did not need any water that is why the water is not on. Mr. Marcombe stated after she got out of jail, she unscrewed the doors and went back in. Councilwoman Racca questioned if he had contacted the Police Department to have her removed? Mr. Marcombe stated no and now he has to go through the legal process and evict her. Mayor Bourque stated the woman throws her fecal matter on the ground and as the owner it is his legal responsibility to handle this. Ben told Mr. Marcombe he had contacted him and made him aware of this. Mr. Marcombe stated he did not recall that. Mayor Bourgue recommended the council move forward on the condemnation and have Mr. Marcombe allow Mr. Richard to go inside the mobile home for inspection and see what needs to be done to make sufficient repairs. Councilman Higginbotham questioned how long should we give him? Gerald recommend this be tabled till the next meeting and Mr. Richard will make a recommendation at the next meeting. Mr. Marcombe stated the tenant is being evicted on Monday.

Discussion: Mayor Bourque stated DOTD will be constructing the overpass on Hwy 90 @ Ambassador. This is a 140 million improvement. We have a 12" waterline in the State right of way. It is our responsibility to move the waterline and we do not want to do that. We will supply the inspection. Daniel Hutchinson stated the current estimate is 2.1 million to move the water line.

We have requested thru Capital Outlay financial assistance. There is no budget amendment needed for this. We are obligated by contract to do this. This water line was installed between 1996-1997. It is our responsibility to move it out of the right of way. He feels the legislative delegation will help. They do offer 0% interest loan to move the lines.

Mike stated we are limited of what can be done on the west end due to the census blocks. There is a lot of density there. Councilman Higginbotham stated in David's Plan 5 he grew up in that area; so, he feels Davids' plan is more continuous to his own home. Mike stated it is up to the council. Councilwoman Racca stated she did speak to all of the council and the constituents in her district, and she is asking the council to go with Map 4A.

Councilman Delahoussaye stated what concerns him is we introduced Map 4A over 30 days ago and tonight we are presented with Map 5, when it should have been brought up before this. He is sticking with Plan 4A.
