6. OTHER BUSINESS

6.1 Condemnation Report of 307 Third Street (Gery Marcombe Property)

Ben stated that he has made several visits to the site. The roof has been cleaned and the sewer stub out has been repaired. The shed in the back has been boarded up and the trailer is up for rent. He has done everything that he was asked to do. Councilwoman Racca stated it has taken him awhile, but she is

satisfied with what he has done. Ben stated he will keep monitoring the property. Councilman Racca stated he has multiple properties, hopefully he can continue to clean up all his properties. She also added if any other problems arise in that area, she will contact the Chief of Police about it.

6.1 Condemnation Report @ 200 St. Des Porres (Sharon Norbert Property)

Ben stated he spoke to Ms. Norbert and her architect, and they have provided a layout for the building to move forward. Ben stated they are going thru the right process. They will have a lot of hurdles to go thru, because they are in the Old Town Overlay District. Councilman Rabon stated he is satisfied with the plans. He questioned how long will she need to move forward with the plans, 2 – 3 weeks?

Ben stated she probably will not have a complete set of plans for 30 days. Ms. Norbert stated she could not say exactly how long she will need, because she doesn't know how long it will take. Ben suggested we give her 60 days to get the plans submitted to the State Fire Marshall's Office. They will have to go back and forth. He feels 60 days is a reasonable amount of time. The council agreed and Ben will report back to the council in 60 days.

Variance request on basic flood elevation for a proposed shed
