#### 4.1 Karen Cox

Introduction of New Business

#### 4.2 Travis Laurent & Brian Boudreaux

Variance request for Villa's on Jefferson Street for rear set-back

Motion by Councilman Delahoussaye

Second by Councilman Regan

Discussion: Mr. Boudreaux explained to the council that this variance is needed to put the a/c pads behind the home which will be within the public drainage easements. They are asking for a variance to allow the a/c units to be put there. There are 9 units. Mayor Bourque stated the rear drainage was a private drainage, then it was donated to the city. The issue is the a/c pads will incumber the public drainage access. Councilman Higginbotham questioned, what is the size of the a/c

pads, and will this impede on the drainage flow? Travis Laurent stated the size of the pads are 4 x5. The ditch is sub-surface, and they will add additional inlets which will be better. They also have storm water retention on Madison Street. Walter stated the a/c pads are in a drainage servitude. If for any reason we have to get in there, we will have to move the a/c units along with the pads. Councilman Delahoussaye, questioned why did we take over this drainage easement? Walter stated because the drainage runs into this area from other adjacent properties. Mel stated we can clean from Madison Street with the suction truck; but if it collapses then we can't do anything. Councilman Delahoussaye stated why did we accept it, in order to clean it? Is there no way to get to the rear of building to do the cleaning? Councilman Bonin stated we did this to watch what was being built. Councilman Delahoussaye stated we are not passing over the drainage easement with cars. Councilman Bonin stated it is our liability if we smash one of the a/c's; so why don't we give the drainage easement back to the developer or let's abandon the easement. Councilman Delahoussaye suggested we approve the variance. Council Bonin stated he is concerned about the cities liability if an a/c gets damaged. Councilman Higginbotham stated we have easements for a reason, that's why he doesn't agree with giving them the variance. Mr. Cliff Guidry, owner of the development approached the council and stated he is in favor of giving authority if the easement needs to be cleaned in the future. With the rains we have had in the past months, there hasn't been any issues there at all. Attorney Oscar Reed stated we can abandon the back right of way and have the owner give us a temporary easement along with a hold harmless. The council and developer agreed on this and Attorney Reed will prepare the act of abandonment and hold harmless for the next meeting. Original motion was changed as follows.
