4.1 Burton Kolder/Brad Kolder

Approval the 2021/2022 Audit Report

Discussion: Brad and Burton Kolder addressed the council with some of the highlights of the report. Brad explained in the Utility Fund the rate adjustments we have been doing the past few years are moving us into the right direction. In the water fund we did have a large increase of \$183,000 for materials. Karen stated this is the cost to relocate the lines on Highway 90. The State, is in turn reimbursing the city. Burton stated the City is getting closer where we need to be with the rate adjustments. On page 73, of the audit the Parks and Recreation was highlighted. Brad stated the variance in revenues and expenditures from 2021 to 2022 is not a lot. Without the depreciation, the park would be cash positive. Burton stated on Page 1 of the handout, the Tax Revenues came in \$500,000 above what was budgeted. Licenses and Permits are also \$84,000 above what was budgeted. Total Revenues Budgeted in the General Fund were \$28,358,574 and Actual received is \$29,245,125 a variance of 3.13% over budget, which is very good.

The expenditures are \$125,000 less than what was budgeted, which is a 0.41% variance which is great. On page 58, of the Balance Net Position, the city total assets are \$124,899,825 and the liabilities are \$7,609,107. Out total net position is \$76,038,965. Burton stated all together the city has 4 ½ months of surplus without taking in a dime. In the General Fund the city is very strong with 225 days of surplus or 7 ½ months. Burton stated this is a very good report. He complemented the staff and the mayor and council on this.
