#### 3. OTHER BUSINESS:

3.1 Condemnation of 204 South Lee Street (Andre and Mary Stutes Property)
Moved by Councilwoman Racca

Second by Councilman Delahoussaye

Discussion: Mayor Bourgue stated the recommendation from Mr. Richard is to condemn and demolish the property. The pictures give good detail of the status of the property, which is in a deplorable condition. The house is rotting from the inside out. The electrical box needs to be redone and there are also electrical wires underneath the house. The floor joists are loose and no one should be renting this house. Mr. Richard stated when he did the inspection the house was vacant. Mr. Brandon Touchet, who is a representative thru Social Security that helps Mr. Stutes with his finance and properties, addressed the council for Mr. Touchet. Mr. Stutes is unable to speak tonight because of a medical condition he has. Mr. Touchet stated they were finally able to evict the tenant who was living there, and he did destroy the home. They recently spoke to Ben about the condition of the home. Mr. Richard stated his recommendation is that the home be condemned and demolished. Mr. Richard stated they can tear down the home themselves to prevent a tax lien. Mr. Touchet stated that Mr. Stutes is on a fixed income, but he does agree the home needs to demolished. Some residents in the area had the following comments about this condemnation. Mrs. Heidi Girouard stated she is here to make sure it gets condemned. She is in support of it getting condemned and demolished. Ms. Tina Barras stated she totally agrees it needs to be demolished. She lives across the street and there are squatters there along with a lot of traffic going in and out. Mr. Arthur Kern stated he lives at 202 East Madison and he has been there for 25 years. He has seen good people come and go, but the last few years it has mostly been bad people. He is highly in favor of demolishing the property. Mr. Mark Warren stated the property is in his back door. He has had to call the police several times and get squatters out. There is also a lot of narcotic activity there. He has a 13 year old and an 8 year old son and he doesn't want that near his home. Councilwoman Racca stated we had numerous complaints from all the neighbors in the area about the activity at the home and with the condition of the home, she is definitely recommending it be condemned and demolished. Mr. Richard and Ben will consult with the owner about the demolition of the home. Councilwoman Racca questioned what is the time frame this will take? Gerald stated the administration will work with the property owner and determine that.

3.2 Condemnation of 308 Avenue C (Gery Marcombe Property)

Moved by Councilwoman Racca

Second by Councilman Bonin

Discussion: Mr. Richard stated the home has rotten windows, rotten steps, and the electrical wiring is exposed. There is a tree limb on the roof of the house. All the wiring needs to be redone. The home needs a lot of electrical, plumbing and carpenter work. Mr. Marcombe stated he would like a chance to repair the home. Mr. Richard stated it needs a lot of loving care. The wiring needs to be re-wired and the seals need to be fixed. Mr. Marcombe stated some windows do need be replaced. The steps are aluminum, but they may need some repairs. Councilman Delahoussaye questioned Mr. Marcombe why does it take 2 times for him to address the issues with his rental properties? This is the second time one of his properties is brought to the council for neglect. Councilwoman Racca stated the property has been vacant since September/October of last year. The windows are broken. This is a safety and health issue and a threat to the neighbors. Councilwoman Racca stated she feels he has ample enough time repair the home. Right now, the back door is currently open. Mr. Marcombe stated that is because he has people working inside. Councilman Delahoussaye questioned, when are they working, because he passed by multiple times in the past few weeks and no one was ever there working. Mr. Marcombe stated he has hauled multiple pile of trash out of the home already. Mr. Richard advised Mr. Marcombe that if the council allows him to repair the home it will have to be a state licensed plumber, electrician, and contractor. Mayor Bourque advised Mr. Marcombe that as a property owner it is his obligation to keep up his properties to a certain level. This is a very expensive repair project. Chief Olivier stated just the other day the house was opened and they went to check the home and there was a painter there, who was just putting blotches of paint on the walls. He also had to run people out of there that were sqautting there. Chief Olivier stated he needs to block the doors and windows to avoid people from going in there. The house needs to be boarded up completely. Councilman Delahoussaye questioned Mr. Richard for a professional recommendation on the cost to repair the home. Mr. Richard stated it would take \$20,000 - \$30,000 easy to repair it because it is 50% destroyed. Councilman Delahoussaye asked Mr. Marcombe if he has the funds to repair the home. Attorney deLauanay stated the council can ask whatever is appropriate for Mr. Marcombe to do. He has to abide by the conditions the council sets forth, or it will move forward. Councilwoman Racca stated the home has been vacate and Mr. Marcombe has already come to the council about his other properties. It is not fair to the neighbors in that area to have to have to continually deal with this; therefore, she is recommending it be condemned and demolished.

Councilman Bonin questioned why Papa Joe is not on the list from Patrick to Huval, which is starting to deteriorate, also Attie Circle. Mel stated the first 2 can be done now, and the other 4 can easily be preserved. Councilman Bonin requested we also figure in Attie Circle. Karen explained the funding for this comes from the 1992 Sales Tax. There is a surplus of \$300,000 with doing a saving spend. Mel explained the process of asphalt deteriorating and how can

roads be saved and not reconstructed. Councilman Bonin stated he would like this ordinance to be amended at the next meeting to include the funding for Papa Joe Drive and Attie Circle.
