Discussion: Councilman Bonin questioned Mel if he has the cost for the entire length of Papa Joe Drive and Attie Circle? Mel stated it would be an additional \$67,623 for Papa Joe Drive and an additional \$36,820 for Attie Circle for a total of \$104,443. Councilman Bonin stated he knows it is a lot, but it is ridiculous to do these projects and stop in the middle of the streets. Councilman Regan questioned what is the cost incentive to mobilize the crews? Mel stated they would be mobilizing anyway. Councilman Regan questioned Karen about the additional funds? Karen stated we had \$300,000 unused in our revenues. Any amended amount would be a savings draw from the 92 Sales Tax fund. Councilman Regan stated he would like to see it done all at once.
