4. OTHER BUSINESS:

4.1 Suzanna Morton w/ LOPA Making Life Happen

National Donor Month

Ms. Morton addressed the council regarding LOPA. April is National Donor Month. The support from this community is incredible. Right now, there are 100,000 people in need of a transplant in the USA; 2,000 of those people are from Louisiana. On April 4th, there was a flag raising ceremony at St. Julien Park for LOPA. This was a great opportunity for remembrance. There was also another gathering this past Saturday, where every family released a butterfly in remembrance of a loved one. She thanked the city for everything they have done for LOPA. Mayor Bourque stated the city is proud to have partnered up with LOPA.

4.2 Heather Broussard w/Mazie's Mission

Water Safety Awareness

Suzanne Morton introduced Heather Broussard, the founder of Mazie's Mission. Mrs. Broussard's daughter was honored Saturday, which was the day of her birthday. Mrs. Broussard stated she is a resident here and she is passionate about this community. In October of 2020, their daughter Mazie, who was 17 months old at the time drowned. It was a traumatic day in their family's life. She stated the State of Louisiana is lacking water safety awareness. So, the family started a non-profit organization, whose goal is to make everyone aware of water safety to save the lives of children and adults in water.

They are very grateful to meet with the Mayor, Callie, and Councilman Forbes about this. There are a lot of subdivisions with ponds and parents need to focus on their children when they are around these ponds. Mayor Bourque stated signage was created to be placed at the ponds at St. Julien Sports Complex. The QR Code on the sign brings you to the website for the Mazie's Mission Foundation where there is a lot of information about water safety.

4.3 Castle 2020 LLC

Condemnation of property located at 508 Avenue C

Discussion: Mr. Rodney Richard stated he submitted the report to the council recommending the property be condemned. Mr. Richard met with Dan Bourque who is purchasing the property and is set to close on the property on May 30, 2023. Mr. Bourque was considering renovating the property, but after speaking to Mr. Richard he realizes the property is beyond repairs. Mr. Richard stated he recommended to Mr. Bourque that he come tonight to address the council about this. Mr. Bourque was unable to be here tonight, but his finance' Noel Jones addressed the council. Ms. Jones stated they will purchase the property on May 30, 2023. They will need 4 – 6 weeks to start the condemnation after the purchase. Then they will need 4-6 weeks to complete the demolition. They should be finish by July 15th. Mayor Bourque stated the condemnation will be on the property. The buy-sell agreement is in place. It is up to the council on how they want to proceed. Councilman Racca stated she agrees the property needs to go thru condemnation. She also understands it was Dan Bourque's parents' home, therefore she has no problem granting the extension of the completion of demolition of the property till July 15th. Ms. Noel also stated they own other properties in the area surrounding and they are in the process of cleaning up those properties also. Motion by Councilwoman Racca

An ordinance amending the 2022/2023 Operating Budget of Revenues and Expenditures for an additional \$40,700 for safety barricades along South Bernard Road Moved by Councilman Bonin

Discussion: Mr. Rob Bunch explained to Councilman Regan what happened on the January 12th when a vehicle went thru his home, being he was not in attendance at the last meeting. At the last meeting Councilman Delahoussaye was concerned that if this would be approved, then ever other neighborhood would also want this. Bunch stated, well this isn't like every other neighborhood. This is the third incident where a vehicle goes off this road in this area. He has \$65,000 worth of damage and the driver had no insurance. No matter what the cost is, you cannot put a price on someone's life. That is why he is asking the council to approve this. This will directly affect 10 homes in that area.

Ms. Ashley Landry addressed the council. She is asking for the council to support this. There have been 2 serious accidents on that road in one week, thankfully no one was injured. She is asking the council not to wait till someone is seriously hurt. Yes, there is a lot of speeding on that road, but the police cannot be there 24 hours a day. The cost of this is about the total salary of one employee. Councilman Bonin stated we can talk

politics about this all day long. This is a no brainer and needs to be done. He is in favor of this.
